Inadequate instruction and/or control of participants causing distraction leading to accident/injury	Instructors & Participants	<ul style="list-style-type: none"> <li>ensure the instructor has attended an appropriate training course and has an in date first-aid qualification.</li> <li>have a group-specific risk assessment in place prior to the session.</li> <li>ensure there is at least one responsible adult, in addition to the Session Leader, to help manage behaviour.</li> </ul>	
Defective equipment causing injury	Instructors & Participants	<ul style="list-style-type: none"> <li>check all equipment before and after the session and remove any faulty axes from use.</li> <li>report any damage to the Operations Manager.</li> </ul>	
Release of axe behind thrower causing injury	Instructors & Participants	<ul style="list-style-type: none"> <li>ensure that axes are held correctly.</li> <li>ensure that spectators stand to the side of throwers and not directly behind them.</li> </ul>	
Injury caused by dropping an axe blade	Instructors & participants	<ul style="list-style-type: none"> <li>instruct participants to wear suitable footwear i.e. walking boots before the event.</li> </ul>	
Slips, trips and falls causing injury	Instructors & Participants	<ul style="list-style-type: none"> <li>ensure that all participants walk when on the range.</li> </ul>	

## Risk Assessment

Injury due to unsafe transport/handling of equipment	Instructors & Participants	<ul style="list-style-type: none"> <li>ensure that axes are sheaved and carried across site in a locked box.</li> <li>ensure that when an individual axe is handled it is held to the side of a person, by the head, with the sharp edge away from the body.</li> <li>ensure the axes are locked away securely.</li> </ul>	
Injury caused by an axe blade	Instructors & Participants	<ul style="list-style-type: none"> <li>ensure there is a first-aid box.</li> <li>report any accidents or near misses either via the QR code displayed on site or failing that directly to the Operations Manager.</li> </ul>	

### Review due:-

A risk assessment needs reviewing if circumstances change but also schedule regular reviews to ensure they are current, recommended every 12 months? The review must include a detailed look at each element of the risk assessment in order to establish if any change is required.

Don't forget, as part of your programme planning, you should have contingency activities in reserve just in case you can't do what was planned or you need to stop halfway through. Make sure this is shared with those involved, so everyone knows how to respond. You should have risk-assessed contingency activities prior to them taking place and communicated key information to those involved, as with all activities.
